## *COMPASS Seeks Public Comment on Regional Transportation Projects*

Projects will be on display at COMPASS on July 19, 2006

*Meridian* – The Community Planning Association of Southwest Idaho (COMPASS) seeks public comment on transportation projects proposed for the next five years in the Treasure Valley, specifically, the Northern Ada County and Nampa Urbanized Area *Preliminary Transportation Improvement Programs for FY2007-2011*, and the required *Air Quality Conformity Demonstration for Northern Ada County*. Documents will be available for review on or after July 6, 2006 and comments will be accepted from July 6 through August 3, 2006.

*Transportation Improvement Programs* allocate limited federal transportation funds for projects such as highways, transit, pathways, rail crossings, vanpooling, and other public transportation options.

The *Air Quality Conformity Demonstration* is required for air quality non-attainment and maintenance areas, such as Northern Ada County, and shows that projects listed in the *Transportation Improvement Program* and draft regional long-range transportation plan, *Communities in Motion*, will comply with state air quality plans. Federal government approval of the *Air Quality Conformity Demonstration* is necessary to obtain final approval of the *Transportation Improvement Program*.

**TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

COMPASS prepares and adopts the TIP every year in cooperation with the Idaho Transportation Department (ITD), local highway districts, local governments, and other project sponsors. What is the TIP?

1) The TIP is a five-year schedule and cost estimate of federally-funded and regionally significant transportation projects within Ada and Canyon Counties.

2) The TIP is an extension of the long-range transportation plan. The long-range plan suggests transportation improvements needed in the region over the next 25 years. The TIP illustrates those projects listed for funding and construction in the short-term. A project cannot be in the TIP without first appearing in the long-range plan.

3) The TIP is required by the U.S. Department of Transportation so that our region can receive money from the federal government for transportation projects. A transportation improvement is not eligible for federal funding unless it is listed in the TIP.

4) The TIP is a plan for improving the transportation system that must also meet air quality improvement standards for Northern Ada County, where air quality has been a concern.

***What is COMPASS?***

COMPASS is the Metropolitan Planning Organization for Ada and Canyon Counties, with responsibility for transportation planning and allocation of federal transportation funding. The COMPASS Board consists of elected officials representing cities, counties, the transit authority, highway districts, and special districts in the two-county region.
