Chair Dale called the meeting to order at 1:40 p.m.

AGENDA ADDITIONS/CHANGES

None.

OPEN DISCUSSION/ANNOUNCEMENTS

Tom Dale announced that the International Association for Public Participation (IAP2) selected ***Communities in Motion: Regional Long-Range Transportation Plan 2030*** as a 2007 Project of the Year Merit Award winner. The award was presented at the annual meeting of IAP2 on November 15, 2007. The COMPASS project was one of five awarded, from a slate of 22 projects worldwide. COMPASS was acknowledged for its use of innovative public participation techniques and for successfully involving the public in the planning process.

Elaine Clegg moved and Carol McKee seconded approval of the Consent Agenda as presented. Motion passed unanimously.

ACTION ITEMS

- A. Adopt Resolutions to Amend the FY2008-2012 Northern Ada County Transportation Improvement Program and Communities in Motion**

Charles Trainor presented Resolutions 01-2007 and 02-2007 to amend the FY2008-2012 Northern Ada County Transportation Improvement Program and *Communities in Motion*.

After discussion, *Elaine Clegg moved and Garret Nancolas seconded approval of Resolution 01-2008, approving the air quality conformity findings and adopting an amendment to Communities in Motion, the regional long-range transportation plan, as presented. Staff was directed to send a letter with the amendment to the Idaho Transportation Department stating the COMPASS Board supports the land use scenario in Communities in Motion be followed for Eagle Road and that the Idaho Transportation Department's bicycle and pedestrian improvements on Eagle Road be followed as well. Motion passed unanimously.*

After discussion, *Elaine Clegg moved and Carol McKee seconded approval of Resolution 02-2008, approving an amendment to the FY2008-2012 Transportation Improvement Program for Northern Ada County and the associated air quality conformity demonstration as presented. Motion passed unanimously.*

INFORMATION/DISCUSSION ITEMS

A. Review Homebuyers Survey Report

Carl Miller reviewed the Homebuyers Survey report, which identifies the reasons for people buying homes in the Treasure Valley. This information will be used in the allocation of future population forecasts.

B. Review September 2007 Statewide Survey on Transportation Funding

Ken Burgess recapped the federal appropriations process and reviewed the statewide survey regarding transportation funding conducted by Moore Associates in September 2007.

C. Review Growth Projection Options

Carl Miller reviewed growth projection options, which establish a framework for understanding future development patterns and transportation conditions.

D. Status Report – Finance Committee

A.J. Balukoff, Chair of the Finance Committee, stated due to lack of quorum the Finance Committee did not meet as scheduled on November 16, 2007 to review the year-end variance report and Revision 1 of the FY2008 Unified Planning Work Program and Budget. A.J. said he had spoken to members of the Committee and it was agreed they had no changes to the year-end variance report. Since it is the year-end report it will be subject to review as part of the 2007 audit process. A.J. stated that the Committee will meet and review Revision 1 of the budget and will have a recommendation for the Board at the December 17, 2007 meeting.

E. Review Proposed Transportation Improvement Program Amendment Policy

Toni Tisdale presented a proposal to streamline Transportation Improvement Program amendments by categorizing changes in either major amendment or administrative modification.

After discussion, *Chair Dale asked for any objection to amending the policy to state that COMPASS Board members will vote on major modifications and will receive notification of all administrative modifications. Hearing none, Chair Dale so ordered.*

F. Review Proposal for COMPASS to Facilitate Transportation Project Coordination

Charles Trainor reviewed the three options for COMPASS to facilitate transportation project coordination. Alison Lantz from the Idaho Transportation Department provided a brief review of the CARS 511 system. Staff will bring this item back to the Board for further discussion.

Chair Dale called the meeting to order at 2:12 p.m. General discussion took place due to lack of quorum.

Quorum was reached at 2:30 p.m.

CONSENT AGENDA

- A. Approve September 18, 2007, Executive Committee Meeting Minutes**

Tammy de Weerd moved and Frank McKeever seconded approval of the Consent Agenda as presented. Motion passed with Elaine Clegg abstaining.

ACTION ITEMS

- A. Establish November 19, 2007, COMPASS Board Meeting**

Matt Stoll presented staff proposed Agenda Items 1-17 for the November 19, 2007, COMPASS Board meeting and requested to add Agenda Item 17b – Confirm A.J. Balukoff as the COMPASS representative on the Treasure Valley High Capacity Transit Study Downtown Policy Advisory Committee under the Consent Agenda and add Agenda Item 17c – Review Analysis for COMPASS to Facilitate Transportation Project Coordination under Information/Discussion Items.

After discussion, *John Franden moved and Frank McKeever seconded approval of the November 19, 2007, COMPASS Board meeting Agenda Items 1-17c as presented. Motion passed unanimously.*

INFORMATION/DISCUSSION ITEMS

A. Status Report – State Legislative Issues

Matt Stoll discussed the results of the September 2007 statewide survey regarding transportation funding and proposed legislation for the 2008 legislative session. He stated he, Kelli Fairless, Ken Burgess and Roy Eiguren will be meeting with local councils and commissions over the next 60 days regarding the local option tax legislation.

After discussion, the Committee directed Matt to work with Kelli to prepare a draft resolution of support for the local option tax legislation for each of the member agencies approval. The goal is to demonstrate to the legislature that there is a unified front among the Treasure Valley leaders.

Chair Dale directed staff to schedule a training session on the local option tax legislation in mid-November for newly elected officials.

Matt announced that COMPASS and Valley Regional Transit will host a legislative reception on Thursday, January 31, 2008, from 5:00 -7:00 p.m. at Plaza 121 in Boise.

B. Status Report – FY2009 Federal Appropriations Requests

Toni Tisdale reviewed the proposed process and schedule for submitting FY2009 federal appropriations requests based on new rules: 1) only two requests for each appropriations bill are now allowed, and 2) requested projects must be able to be paid for within three fiscal years.

Matt stated that staff will bring recommended FY2009 requests to the Executive Committee at the November 20, 2007 meeting.

C. Review Proposed Amendment Policy for Transportation Improvement Programs

Toni Tisdale reviewed a proposed policy to amend the transportation improvement programs. This proposal still allows review of all changes by the Regional Technical Advisory Committee and the COMPASS Board; however, administrative changes are approved by the Executive Director. This change allows for more timely response to member agencies.

GARVEE-related project changes require 2-4 weeks for the Interagency Consultation Committee (ICC) to approve changes. Changes can be handled through an email notice, per ICC policy. Non-GARVEE related project changes require a 30-day notification and formal ICC meeting, extending the approval process to 6-8 weeks.

Staff will be requesting COMPASS Board approval at the December 2007 meeting.

D. Executive Session – Personnel Matter [Idaho Code 67-2345 (b)]

John Franden moved and Tammy de Weerd seconded to move into Executive Session pursuant to Idaho Code 6702345 (b) at 3:30 p.m.

Matt Stoll called roll. *The following Executive Committee members were present and voted in the affirmation to adjourn into Executive Session: Tom Dale, Elaine Clegg, Tammy de Weerd, John Franden and Frank McKeever. There were no nay votes.*

John Franden moved and Elaine Clegg seconded to move back into regular session at 3:45 p.m. No action was taken in Executive Session personnel issues were discussed. Motion passed unanimously.

Topic: Policy for Transportation Improvement Programs

Summary:

Current procedure for amending the Transportation Improvement Programs includes COMPASS Board approval for most actions. This procedure can take a month or longer for full approval. When dealing with construction projects, timeliness is imperative in order to keep projects progressing. Staff is proposing a new policy (Attachment 1) to streamline the amendment process. The proposed policy was presented to the Board on November 19, 2007. Staff received one recommended change, which was added: members of the COMPASS Board and the Regional Technical Advisory Committee will be notified in advance of Administrative Modifications.

Staff Recommendation/Request:

Staff recommends Board approval of the new Transportation Improvement Program Amendment Policy. The Regional Technical Advisory Committee recommended approval of the policy on September 26, 2007.

Implication (policy and/or financial):

Approval of this policy will provide an efficient method of amending the Transportation Improvement Programs. Until the new policy is approved, current procedure will be followed.

Highlights:

Following are some of the highlights of the proposed amendment policy:

- Any project that is new, removed, or adds capacity to a roadway must be noticed and public input received before it is brought to the COMPASS Board for action.
 - These amendments may trigger an amendment of the air quality conformity demonstration as well.
- A change in dollar amount exceeding \$2 million or 20% of the total project cost (whichever is less) must be approved by the COMPASS Board.
- Discretionary funding is considered an administrative modification and may be approved by the COMPASS Executive Director.
- Minor adjustments such as transit budgetary adjustments, key number changes, or shifts in funds within the same project and fiscal year may also be approved by the COMPASS Executive Director.
- The COMPASS Board will be apprised of all changes through an Executive Director's Report in the COMPASS Board packet.

Topic: Priorities for FY2009 Appropriations Requests

Summary:

The Idaho Congressional delegation placed the following new eligibility limitations on the FY2009 Appropriations Earmark process:

- A maximum of two requests for each appropriations bill.
- Projects should limit their funding requests to a maximum of three fiscal years.

Although the FY08 Appropriations process is not yet complete, the following two COMPASS projects are expected to receive some funding in FY2008:

- I-84/Exit 29 local projects in Caldwell, and
- Regional Transit Facilities project

Our legislative lobbyist, Veritas Advisors, recommends requesting continued funding for these projects in FY2009. The COMPASS Executive Committee recommends following the advice of our advisor in requesting additional funds for these two projects.

Staff Recommendation/Request:

Staff recommends approval to request funds for the Exit 29 local projects in Caldwell and the Regional Transit Facilities project for FY2009 Appropriations Earmark funding.

Implication (policy and/or financial):

At the request of the Congressional delegation, it has been the policy of the COMPASS Board over the last two years to maintain consistency in requests for Congressional Earmark funds. Applications are due February 11, 2008. Staff needs adequate time to prepare the applications and secure letters of support for the priority projects.

Highlights:

Last year, COMPASS requested funding for four projects through Appropriations funding: two roadway and two transit. At this time, the two projects nominated by the Executive Committee are listed for funding in the FY2008 Transportation Bill to receive funding. However, the bill is not yet signed. The Executive Committee suggested these projects as priorities. If they do not remain in the signed bill, other priority projects may be considered.

Topic: Transportation Improvement Program Amendment

Summary:

The FY2008-2012 Northern Ada County and Nampa Urbanized Area Transportation Improvement Programs were approved by the COMPASS Board on August 20, 2007, followed by approval of project changes through the mirroring process on October 15, 2007. The documents were not approved by the Federal Highway Administration because there were discrepancies between the state and local programs.

Staff Recommendation/Request:

Staff recommends approval of Resolution 03-2008 (Attachment 1) amending the FY2008-2012 Northern Ada County and Nampa Urbanized Area Transportation Improvement Programs. The Regional Technical Advisory Committee recommended approval of the changes detailed in Resolution 03-2008 on November 28, 2007.

Implication (policy and/or financial):

The FY2007-2011 Transportation Improvement Programs are in effect until federal approval of the FY2008-2012 programs. Without approval of the proposed changes and subsequent federal approval of the FY2008-2012 programs, member agencies may not be able to obligate needed funds in FY2008.

Highlights:

There are several reasons for the discrepancies between the state and local programs:

- Most of the changes are affiliated with the GARVEE program, which had last minute changes.
- Some rail safety projects scheduled for FY2007 did not deliver. ITD has requested to add these projects to the FY2008 program.
- Other minor changes to the Expansion program are related to mathematical errors.

These changes do not require public comment or additional demonstration of air quality conformity. Details of all changes are available as an attachment to Resolution 03-2008.

Topic: 2008 Idaho Legislative Session Priorities

Summary:

The Executive Committee at its November 2007 meeting identified four issues to focus COMPASS' legislative efforts for the 2008 legislative session. Staff crafted proposed position statements based upon Executive Committee's recommendations for the following issues:

1. Transportation Revenue

The COMPASS Board of Directors strongly supports legislation increasing revenue for the transportation system including transit and alternative transportation modes in the State of Idaho. The Forum on Transportation Investment identified a \$200 million per year shortfall for critical local and state transportation projects over the next 30 years. A functional transportation system is critical to accommodate the population growth and economic development of the Treasure Valley and the state of Idaho.

2. Transportation Local Option Tax Authority Legislation

The COMPASS Board of Directors strongly supports legislation providing the creation of Regional Transportation Authorities and the ability to request necessary supplemental transportation revenue from citizens through a local option sales tax. The Board supports the concept of allowing such funds to be used for both roadway and transit projects, and opposes any legislation that excludes the possibility of funding transit options through local sales tax. The local option sales tax concept is proposed by the Coalition for Regional Public Transportation, a coalition of business and elected leaders of the Treasure Valley.

3. Third Year Funding Approval of GARVEE Bonding Program

The COMPASS Board of Directors strongly supports continuation of the Idaho Transportation Department's proposed GARVEE-related project and funding package. The GARVEE program is a critical tool in Idaho's efforts to meet the challenges and demands of a growing economy and population. The GARVEE program allows the Idaho Transportation Department to expedite critical projects in a cost efficient manner. Construction of the transportation corridors in Ada and Canyon Counties, as originally identified in the Connecting Idaho Program should remain a priority for GARVEE funding.

4. Transportation Access Plan Legislation

The COMPASS Board of Directors strongly supports legislation providing a mechanism for the Idaho Transportation Department, in cooperation with local planning entities, to define the access control standards for a given highway corridor. This concept will allow transportation planning agencies to protect the safety and mobility of the traveling public by entering into agreements to control and manage access on state highways. This authority would help solve traffic flow challenges on state highways, particularly in high-growth areas like Ada and Canyon Counties.

Staff Recommendation/Request:

Approve the proposed legislative priorities and position statements.

Implication (policy and/or financial):

The legislative priorities and position statements will guide COMPASS staff and consultant in their efforts during the 2008 Idaho Legislature. COMPASS' legislative advocacy efforts were budgeted in the FY2008 Unified Planning Work Program and Budget as approved by the Board in August 2007.

BACKGROUND:

Below is a synopsis of activities and contacts made during the month of November 2007 regarding COMPASS' Federal and State legislative priorities.

STATUS:

FEDERAL ISSUES

1. COMPASS projects survive Conference Committee of Transportation Appropriations: Two COMPASS projects are still included in the Transportation Appropriations Bill, but the amount dedicated to those projects has, predictably, been reduced. Exit 29 Caldwell local improvements is set to receive \$480,000 (down from \$800,000), and VRT's facilities siting plan is set to receive \$288,000 (down from \$470,000). The House has already passed this bill, the Senate has not.

As of today, Congressional leaders are discussing combining all of the remaining 11 spending bills into one, large, "omnibus" package in order to get work completed before Christmas. But to avoid a veto from the President, they may attempt to trim some spending, which will affect earmark figures, including ours.

Congress and President Bush are engaged in a major showdown over spending. There is still an \$11 billion difference between Bush's request and Congressional figures.

Possible permanent continuing resolution looms: If Congress and the President cannot come to some agreement; it is possible that a permanent continuing resolution will be passed by Congress – as happened last year. This scenario would preclude any earmarks from getting funding for the second straight year.

2. Congressman Simpson Meeting: Members of the COMPASS Executive Committee met with Mike Simpson on November 27, 2007. This was a good opportunity to re-iterate our concern over transportation funding, and to discuss our local option sales tax concept. It is clear that he understands the transportation challenges we face in the Treasure Valley. He also indicated that we cannot count on federal funding or earmarks to solve the problem. The state and local communities must find ways to solve some of their own problems. In this respect, he was supportive of the concept of local option sales tax authority.

3. FY09 Federal Appropriations prioritization and application process begins: The Congressional Delegation has issued the call for FY09 appropriations requests. The COMPASS staff and Ken have begun gathering information for prioritizing COMPASS' requests. Two important restrictions have been placed on the requests this year: one is that no single entity may request more than two projects in any single appropriations bill, and the other is that no project extends beyond a total of three years of expected federal funding. These new parameters are a result of earmark reform efforts in Congress, and in preparation for the retirement of Senator Craig in January 2009.

STATE LEGISLATIVE ISSUES

Matt Stoll, Kelli Fairless, and Ken Burgess remain in constant contact with stakeholder groups/lobbyists on a number of Treasure Valley transportation funding issues.

1. Local Option Sales Tax Authority: We continue to play an active role in the Coalition on Regional Public Transportation. The Coalition partners continue to meet with individual legislators, and add to the coalition group.

Matt, Ken, and Kelli have been involved in numerous meetings through the months of October and November 2007 with the Coalition members. We have circulated the first draft of the local option tax authority legislation, met with and received feedback from municipalities, transportation stakeholders, and legislators. This constructive feedback has resulted in a new draft of legislation that will be simpler and more easily applicable to all parts of the state, not just the Treasure Valley.
2. GARVEE Funding: As you may be aware, the ITD Board has delayed their recommendation for the next installment of GARVEE funding. They had been considering requesting an additional approval for GARVEE of \$130 million. At this moment, it appears another round of GARVEE approval may be a tough sell in this year's legislative session. There appears to be increased resistance from the legislature for additional funding for GARVEE. An aggressive effort will be necessary to accomplish the goal. Matt and Ken continue to be involved in the GARVEE Coalition group meetings in preparation for the 2008 legislative session.
3. Public Relations strategy: Ken, Matt, and Terri developed a radio public education campaign regarding overall funding challenges. This initial effort has run a two week cycle on many radio stations during drive time, and is designed to educate the public on the transportation funding needs of Idaho and the Treasure Valley.
4. COMPASS legislative reception: We have made arrangements to host a legislative reception, 5:00 – 7:00 pm on Thursday, January 31, 2008 to be held at the Plaza 121 building (9th and Idaho, downtown Boise). We will recruit COMPASS Board members to greet and escort members of the legislature to our reception that day. More information will be forthcoming.
5. Governor's message: Governor Otter has clearly determined that he needs to take a leadership role on transportation funding issues, by publicly declaring transportation funding a major challenge. The COMPASS Board should re-iterate to your constituents the general message that transportation funding is indeed a major challenge and support the Governor's statements.

We continue to support the Governor's assertion that new funding sources need to be developed in order to meet the transportation needs of the state (and Treasure Valley).
