## Topic: Transportation Improvement Program Amendment

### Summary:

Changes were requested at the Urban Balancing Committee held on March 22, 2010 and the Transportation Management Area (TMA) Balancing Committee held on April 8, 2010. Several of the changes could be handled through an Administrative Modification, which was approved on April 21, 2010. Other changes require a Transportation Improvement Program amendment, which are detailed in Attachment 1, Resolution 11-2010. The changes are recommended by the Urban and TMA Balancing Committees and the Regional Technical Advisory Committee.

### Staff Recommendation/Request:

Staff recommends adoption of Resolution 11-2010 amending the FY2010-2014 Regional Transportation Improvement Program.

### Implication (policy and/or financial):

Without Board approval, this project cannot move forward for funding.

### Highlights:

The Balancing Committees request the following amendment changes:

- Key Number 12046 – Karcher Road and Middleton Road Intersection, Nampa – Advance \$226,000 in design work from FY2012 to FY2010.
- Key Number 10560 – Rideshare, ACHD's Rideshare Program, Ada County – FY2011 – Advance project totaling \$220,000 from FY2011 to FY2010.
- Key Number RC0152 – Franklin Road, Black Cat Road to Ten Mile Road – Reduce scope to only the intersection of Franklin and Black Cat Roads, change funding source from local (regionally significant) to STP-TMA, and advance \$500,000 in design work from PD to FY2010.
- Key Number – NEW – COMPASS Operations – FY2011 – add new project totaling \$306,000 to supplement the planning and operations of COMPASS in FY2010.

All these changes are offset by cost savings on previous projects that were de-obligated and made available. The Nampa Urbanized Area gained additional funds from bid savings in other parts of the state.

This proposed amendment was released for public comment from April 12 through April 26, 2010. No comments were received.

**RESOLUTION No. 11-2010****FOR THE PURPOSE OF AMENDING THE FY2010-2014

**WHEREAS**, the Community Planning Association has developed this amendment to the FY2010-2014 Regional Transportation Improvement Program in compliance with all applicable State and Federal regulations; and

**WHEREAS**, the attached table dated March 22, 2010, details the amendments to the FY2010-2014 Regional Transportation Improvement Program.
