Introduction

The 2010 Development Monitoring Report provides an overview of development trends within Ada and Canyon Counties. The Community Planning Association of Southwest Idaho (COMPASS) has compiled similar reports for Ada County since 1980 and for Canyon County since 1999.

The primary source of data for the Development Monitoring Report is building permits collected from the cities and counties within the region. Another important source of data is preliminary plats, which are subdivisions that have received preliminary approval for development but have not received final approval, and therefore have not been recorded. Preliminary plats represent areas that have a strong probability of future growth. Building permits and lots within preliminary plats are organized according to the following geographies for the purposes of this report:

City Limits are the official jurisdictional and taxing boundaries of the cities. City limit boundaries tend to expand year after year as city councils approve property annexations. Building permits in this report reflect the city limit boundaries as the time of reporting.

Demographic Areas are collections of multiple Transportation Analysis Zones (TAZ) that roughly follow city areas and sub-areas within cities. A TAZ is a special area delineated by state and/or local transportation officials for tabulating traffic-related data. City limit boundaries are continuously expanding. Demographic and TAZ boundaries stay the same for about 10 years and therefore provide a good geographic by which to analyze growth trends within a constant boundary over a range of time.

Figure 1: Total New Construction Permits Issued by Year

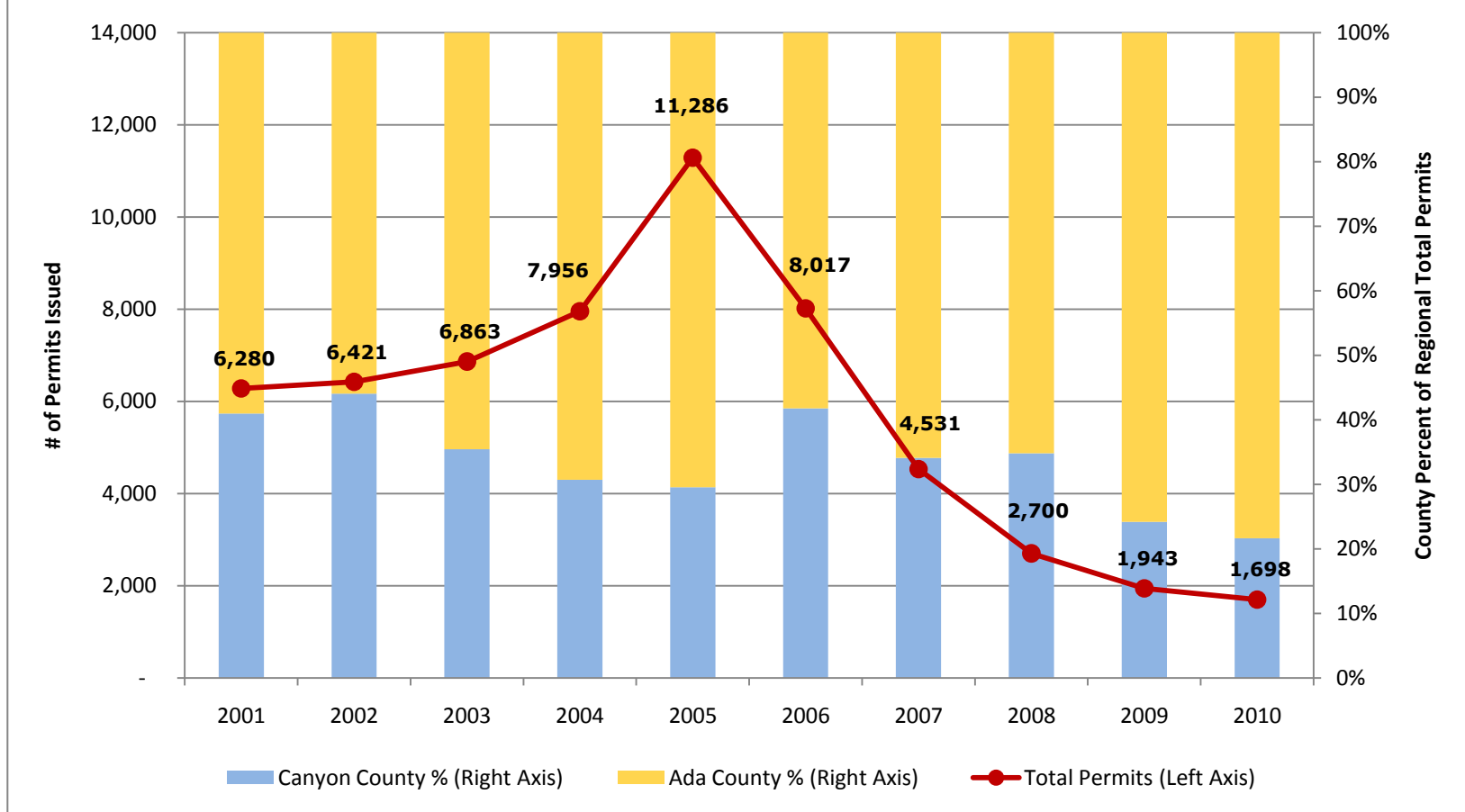
