RE: **Request for Approval of Administrative Modification #16 for the FY2009-2013 Regional Transportation Improvement Program and Administrative Modification #1 for the FY2010-2014 Regional Transportation Improvement Program**

ACTION REQUESTED:

Request approval of Administrative Modification #16 for the FY2009-2013 Regional Transportation Improvement Program (TIP) and Administrative Modification #1 for the FY2010-2014 Regional TIP.

BACKGROUND:

Staff from ITD District 3 requested a transfer of \$1,100 between two companioned projects in Caldwell. The City of Caldwell concurred with these actions. The FY2009-2013 Regional TIP is the approved document at this time, necessitating a change to the FY2009-2013 TIP and the Draft FY2010-2014 Regional TIP.

STATUS:

A summary of changes is shown below, with details provided on Attachment 1.

- Key Number 08075 – Intersection of Franklin Road and 21st Avenue, Caldwell – increase construction funds by \$1,100 from Key Number 09991.
- Key Number 09991 – 21st Avenue, Chicago Street to Franklin Road – deobligate construction funds by \$1,100 and transfer to Key Number 08075.
